The Commission opened this working case at the request of the Office of Public Counsel to consider a rule regarding the reporting of residential customer disconnection data. The Commission initially scheduled a workshop meeting to be held on March 30, 2020, to discuss such a rule. That meeting was indefinitely postponed due to the COVID 19 pandemic. Public Counsel and the Commission's Staff filed a status report on May 29, indicating they tentatively plan to hold an in-person workshop on September 1, 2020, at the Commission's office in Jefferson City. Staff has reserved Room 450 (Ballroom) for that purpose. Public Counsel and Staff ask that they be directed to file a further status report by August 14, 2020, to address the feasibility of holding the workshop on September 1. The Commission will do so.

1. The Commission's Staff and Public Counsel shall file a joint status report no later than August 14, 2020, to address the feasibility of holding a workshop meeting on September 1, 2020.
