## ORDER DIRECTING RESPONSE TO EXPEDITED TARIFF

Issue Date: May 29, 2020

Effective Date: May 29, 2020

On November 25, 2019, Union Electric Company d/b/a Ameren Missouri (Ameren Missouri) filed an Application for Approval to Expand Community Solar Pilot Program and Associated Tariff. On May 13, 2020, the parties filed a unanimous stipulation and agreement that resolved all issues. That agreement called for the rejection of Ameren Missouri's tariff and indicated upon approval of the agreement Ameren Missouri would file a new tariff. The Commission approved the agreement in an order issued on May 28, 2020, with an effective date of June 27, 2020.

On May 28, 2020, Ameren Missouri filed a new tariff purporting to be in compliance with the terms of the approved stipulation and agreement. That tariff carries a 30-day effective date of June 27, 2020, but along with its tariff, Ameren Missouri filed a motion for expedited treatment, asking that the tariff be allowed to go into effect on June 8, 2020 so that it can begin marketing the expanded Community Solar Pilot as soon as possible. For the same reason, Ameren Missouri asks the Commission to change the effective date of its order approving the stipulation and agreement to June 8, 2020 to match the effective date of the tariff that will implement the terms of the stipulation and agreement.

If the Commission is to give an order granting expedited approval of the tariff the required ten-day effective date, it will need to issue that order today, May 29, 2020. For that reason, the Commission will ask its Staff file an expedited recommendation advising the Commission whether the submitted tariff complies with the approved stipulation and agreement. If Staff cannot submit a recommendation within the time allowed, it may file a statement indicating when it will be able to file a recommendation.

**THE COMMISSION ORDERS THAT:**

1. Staff shall file a recommendation regarding Ameren Missouri's compliance tariff (tariff filing number YE-2020-0208) by May 29, 2020, at 2:00 p.m.
2. This order shall be effective when issued.
