ORDER APPROVING EXPEDITED TARIFF AND CHANGING EFFECTIVE DATE OF PRIOR ORDER

On November 25, 2019, Union Electric Company d/b/a Ameren Missouri (Ameren Missouri) filed an Application for Approval to Expand Community Solar Pilot Program and Associated Tariff. On May 13, 2020,¹ the parties filed a unanimous stipulation and agreement that resolved all issues. That agreement called for the rejection of Ameren Missouri's tariff and indicated upon approval of the agreement Ameren Missouri would file a new tariff. The Commission approved the agreement and rejected the originally filed tariff in an order issued on May 28, with an effective date of June 27.

On May 28, Ameren Missouri filed a new tariff purporting to be in compliance with the terms of the approved stipulation and agreement. That tariff carries a 30-day effective date of June 27, but along with its tariff, Ameren Missouri filed a motion for expedited treatment. The motion asks that the tariff be allowed to go into effect on June 8 so that Ameren Missouri can begin marketing the expanded Community Solar Pilot as soon as possible. For the same reason, Ameren Missouri asks the Commission to change the

effective date of its order approving the stipulation and agreement to June 8 to match the effective date of the tariff that will implement the terms of the stipulation and agreement.

The Commission asked its Staff file an expedited recommendation advising the Commission whether the submitted tariff complies with the approved stipulation and agreement. Staff filed its recommendation on May 29, advising the Commission to grant expedited approval of the tariff and to change the effective date of the order approving the stipulation and agreement to match the tariff effective date of June 8. The Commission will do so.

So that the tariff can be made effective at the time requested, this order will be made effective in less than 30 days.

THE COMMISSION ORDERS THAT:

1. The compliance tariff filed by Ameren Missouri on May 28, 2020 and assigned Tariff Tracking Number YE-2020-0208 is approved to become effective on June 8, 2020.

2. The effective date of the Commission's May 28, 2020 Order Approving Stipulation and Agreement is changed to June 8, 2020.

3. This order shall be effective on June 8, 2020.
