On February 3, 2020, Spire Missouri, Inc. (Spire), filed the above-referenced application. The Company amended its application on February 6, 2020. The application seeks, among other things, permission and approval and a certificate of convenience and necessity ("CCN") to construct, install, own, operate, maintain, and otherwise control and manage a natural gas distribution system to provide gas service in Lawrence County, Missouri, as a further expansion of the Company's existing certificated area.

The Commission granted the application on May 28, 2020. As ordered, Spire filed a tariff to reflect its new service territory. The Commission will order its Staff to file a Recommendation regarding that tariff.

THE COMMISSION ORDERS THAT:

1. The Staff of the Commission shall file a Recommendation regarding Spire's tariff no later than June 9, 2020.
2. Any objections to the Staff Recommendation shall be file no later than June 12, 2020.

3. This order shall be effective when issued.
