On May 6, 2020, Evergy Metro Inc. d/b/a Evergy Missouri Metro and Evergy Missouri West, Inc. d/b/a Evergy Missouri West (collectively “Evergy”) applied for an accounting authority order to govern costs and financial impacts associated with the COVID-19 pandemic.

The Commission will set a prehearing conference to discuss a hearing date, other procedural issues and the possibility of agreement on some or all issues. 
