ORDER CANCELING IVOIP REGISTRATION

Issue Date: June 5, 2020

Effective Date: July 5, 2020

On May 20, 2020, Neighborhood Wireless, LLC filed a letter advising that it is no longer in business and asking that its registration to provide interconnected voice over internet protocol (IVoIP) service in Missouri be cancelled as of April 1, 2020. The Commission granted Neighborhood Wireless that registration on June 27, 2018, in File No. DA-2018-0374.

The Commission's Staff filed a recommendation on June 2, 2020, advising the Commission that Neighborhood Wireless has been merged into Wisper ISP, Inc. and no longer needs its registration. Staff indicates Neighborhood Wireless's request to cancel its registration complies with Commission Rule 20 CSR 4240-28.011(3), and recommends the Commission cancel the registration.

The Commission has the authority to cancel a registration pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on the company's request, and Staff's motion, the Commission finds that the registration granted to Neighborhood Wireless shall be canceled.

THE COMMISSION ORDERS THAT:

1. The Registration to provide IVolP services granted to Neighborhood Wireless in File Number DA-2018-0374 is canceled.
2. This order shall become effective on July 5, 2020.
3. This file may be closed on July 6, 2020.
