SECOND ORDER ADOPTING PROCEDURAL SCHEDULE

On February 21, 2020,¹ the Commission issued an Order Adopting Procedural Schedule and setting the case for an evidentiary hearing on May 28. On May 22, the Commission issued its Order Cancelling Hearing, Suspending Procedural Schedule and Directing Filing, ordering the parties to file either an executed Stipulation and Agreement or a Proposed Amended Procedural Schedule no later than May 27. The parties filed a Second Joint Proposed Procedural Schedule on May 27. The Commission will issue a Second Order Adopting Procedural Schedule.

 - Rebuttal to Supplemental Testimony (both parties) July 1, 2020

2. The evidentiary hearing is scheduled for July 27, 2020, commencing at 9:00 a.m. at the Commission's office at the Governor Office Building, 200 Madison Street, Jefferson City, Missouri, Room 310.
