ORDER AMENDING STATUS REPORT SCHEDULE

On September 16, 2019, the Commission was advised the ownership of the assets Missouri-American Water Company (MAWC) sought to acquire was in question. On September 27, 2019, the Commission issued its Order Staying Proceedings. It required MAWC to file monthly status reports commencing November 1, 2019. MAWC has now filed eight monthly status reports. The Commission will amend its order and require MAWC to file status reports every three months, with the next status report due no later than September 1, 2020.

THE COMMISSION ORDERS THAT:

1. Missouri-American Water Company shall file a status report immediately upon the resolution of the asset ownership issues described in the body of this order or, otherwise, every three months, commencing on September 1, 2020, with the report due no later than the first day of the month.
2. This order shall be effective when issued.
