## ORDER CANCELING IVOIP REGISTRATION

Issue Date: June 8, 2020

Effective Date: July 8, 2020

On May 26, 2020, the Commission's Staff filed a recommendation asking the Commission to cancel the IVolP Registration of CorvisaCloud, LLC. The Commission granted CorvisaCloud that Registration in File No. DA-2015-0131, on December 5, 2014.

Staff states in its motion that CorvisaCloud sent an e-mail to Staff on May 7, 2020, indicating its desire to relinquish its Registration. Staff indicates CorvisaCloud's request to cancel its Registration is in compliance with Commission Rule 20 CSR 4240-28.011(3), and asks the Commission to cancel that Registration.

On May 26, 2020, the Commission issued an *Order Establishing Time to Respond*, allowing parties until June 5, 2020, to object or to request a hearing. No objections or requests for a hearing were filed.

The Commission has the authority to cancel a Registration pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on the company's request, and Staff's motion, the Commission finds that the Registration granted to CorvisaCloud shall be canceled.

**THE COMMISSION ORDERS THAT:**

1. The Registration to provide IVolP services granted to CorvisaCloud, LLC, in File Number DA-2015-0131, is canceled.
2. This order shall become effective on July 8, 2020.
3. This file may be closed on July 9, 2020.
