On December 18, 2019, Union Electric Company d/b/a Ameren Missouri (Ameren Missouri) filed a Motion to Delay Procedural Schedule, asking the Commission to delay the remaining schedule until Ameren Missouri's pending electric rate case (File No. ER-2019-0335) was resolved. In response, the Commission suspended the procedural schedule and cancelled the scheduled evidentiary hearing. The Commission will order the Ameren Missouri to file a status report.

1. No later than June 22, 2020, Ameren Missouri shall file a status report.
2. This order shall be effective when issued.
