On May 21, 2020, the Commission issued its *Order Rejecting Tariff to Change Fuel Adjustment Rates*. The Commission rejected a proposed substitute tariff sheet (Tariff No. JE-2020-0171) and ordered The Empire District Electric Company, a Liberty Utilities company (Liberty-Empire) to file any revised tariff sheets necessary to implement interim fuel adjustment rates consistent with uncontested components of Liberty-Empire's proposed rates.

On June 10, 2020, Liberty-Empire filed a revised tariff sheet (Tariff No. YE-2020-0214) to be effective on July 10, 2020. The Commission will order Staff to file a recommendation regarding the revised tariff sheet and will establish a time for response from any other party.

THE COMMISSION ORDERS THAT:

1. The Commission's Staff shall file a recommendation regarding Liberty-Empire's revised tariff sheet (Tariff No. YE-2020-0214) no later than June 17, 2020.
2. Any other party may file a response to Liberty-Empire's revised tariff sheet no later than June 17, 2020.
3. This order shall be effective when issued.
