On June 2, 2020, Tony G. Mendoza and Sunil Bector filed petitions for leave to appear *pro hac vice* as attorneys for the Sierra Club. The Sierra Club was granted intervention in this case on April 1, 2020.

Mr. Bector is not admitted to practice before the courts in Missouri but is a member in good standing of the California State Bar. He states he is not subject to any disciplinary proceedings in any jurisdiction.

Mr. Mendoza and Mr. Bector state that they are associated with Henry Robertson of the Great Rivers Environmental Law Center, who is a member in good standing of the Missouri Bar. Mr. Robertson has previously entered his appearance in this matter. Mr. Mendoza and Mr. Bector also filed proof of their compliance with Missouri Supreme Court Rule 6.01(m).

The Commission has considered the petitions and finds that they comply with the requirements of 20 CSR 4240-2.040(3)(C) and Missouri Supreme Court Rules 6.01(m) and 9.03. The Commission therefore admits Mr. Mendoza and Mr. Bector *pro hac vice*.

THE COMMISSION ORDERS THAT:

1. The petitions for leave to appear *pro hac vice* filed by Tony G. Mendoza and Sunil Bector to appear on behalf of the Sierra Club is granted.
2. This order shall be effective when issued.
