ORDER CANCELING CERTIFICATE

Issue Date: June 15, 2020 Effective Date: June 25, 2020

On April 13, 2020, Twin Valley Communications, Inc. (Twin Valley) notified the Commission that it wishes to voluntarily relinquish its certificate of service authority to provide basic local exchange, non-switch local exchange, and interexchange services in the State of Missouri. The Commission granted Twin Valley a certificate of service authority on May 2, 2013, in File Number CA-2013-0437. Twin Valley does not have a currently effective tariff.

On April 16, 2020, the Commission established a time to intervene to Twin Valley's filing, and directed Staff to respond. On May 29, 2020, Staff filed a recommendation to cancel Twin Valley's certificate of service authority. No objections or requests for a hearing were filed. The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing.¹

The Commission has the authority to cancel a certificate pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate of service authority may be

altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on Twin Valley's request and Staff's recommendation, the Commission finds that the certificate of service authority granted to Twin Valley shall be canceled.

THE COMMISSION ORDERS THAT:

- The certificate of authority to provide basic local exchange, non-switch local exchange, and interexchange services granted to Twin Valley, in File Number CA-2013-0437, is canceled.
 - 2. This order shall become effective on June 25, 2020.
 - 3. This file may be closed on June 26, 2020.
