## ORDER APPROVING TARIFF

On May 28, 2020, Spire Missouri, Inc. filed a tariff sheet under Tariff Tracking No. YG-2020-0207 in compliance with the Commission's *Order Granting Certificate of Convenience and Necessity* issued on May 28, 2020. The submitted tariff sheets bear a proposed effective date of June 27, 2020.

On June 5, 2020, the Commission's Staff filed a recommendation that the Commission approve the compliance tariffs. Commission Rule 20 CSR 4240-2.080(13) states that parties have ten days to respond to pleadings unless otherwise ordered. Ten days have elapsed since Staff's recommendation. No party has filed any response to the Staff recommendation. Further, as the application is unopposed, and so that this compliance tariff may go into effect expeditiously on the requested effective date, the Commission will make this order effective in ten days.

The Commission has reviewed the tariff filing and Staff's recommendation and concludes that the tariff sheet should be approved.

**THE COMMISSION ORDERS THAT:**

1. The tariff sheet filed by Spire Missouri, Inc. on May 28, 2020, in Tariff Tracking No. YG-2020-0207, is approved to become effective on June 27, 2020.
