On June 26, 2025, Union Electric Company d/b/a Ameren Missouri filed the above-referenced application. Ameren Missouri wishes to offer retail service to a solar farm operated by New Madrid Solar LLC. Included therewith was a motion for expedited treatment, in which Ameren Missouri asks for a Commission order no later than August 1, 2025.

The Commission will give notice of the application, and will allow an opportunity for interested parties to apply for intervention.

THE COMMISSION ORDERS THAT:

1. The Commission's Data Center shall provide notice of this order to the county commission for New Madrid County, Missouri.
2. The Commission's Public Policy and Outreach Department shall provide notice of this application through any appropriate social media and news media outlets serving residents in New Madrid County, Missouri.
3. Applications to intervene shall be filed no later than July 7, 2025.

4. The Staff of the Commission shall file a Recommendation or an alternative pleading no later than July 15, 2025.

5. This order shall be effective when issued.
