On June 17, 2020, the Commission issued its Report and Order (Order). The Order authorized Missouri-American Water Company (MAWC) to file a new tariff sheet to recover the revenue identified in the Order. On June 17, 2020, MAWC filed its tariff revision under Tracking No. YW-2020-0216. The effective date of the tariff revision as filed is July 17, 2020; however, MAWC requested the Commission approve the tariff sheets to be effective June 30, 2020.

The Staff of the Missouri Public Service Commission (Staff) filed an expedited recommendation affirming that the tariff revision complies with the Commission's Order.

THE COMMISSION ORDERS THAT:

1. Parties wishing to respond to the Staff recommendation must do so no later than noon on June 19, 2020.
2. This order shall be effective when issued.
