On June 17, 2020, the Commission issued its Report and Order (Order). The Order authorized Missouri-American Water Company (MAWC) to file a new tariff sheet to recover the revenue identified in the Order. On June 17, 2020, MAWC filed its tariff revision under Tracking No. YW-2020-0216. The effective date of the tariff revision as filed is July 17, 2020; however, MAWC requested the Commission approve the tariff sheets to be effective June 30, 2020.
