ORDER GRANTING REQUEST FOR EXTENSION OF TIME

On March 20, 2020, Spire Missouri Inc. d/b/a Spire (Spire) filed an application seeking a waiver of Commission Rule 20 CSR 4240-40.030(13)(BB). The Commission directed a recommendation from the Staff of the Missouri Public Service Commission (Staff) due no later than June 21, 2020.

On June 17, 2020, Staff requested an extension to July 31, 2020, to allow time to receive responses from Spire in three data requests. Staff also requests the extension to allow additional time to review the data request responses, to conduct further discovery as needed, and to prepare its recommendation.

Spire responded without objection, but did note that Spire is making efforts to expedite the remaining data request responses to be answered by June 19, 2020. Spire also noted that it is in the process of updating its Distribution Integrity Management Program, which would be aided by Staff's recommendation.

The Commission will grant the requested extension.

THE COMMISSION ORDERS THAT:

1. Staff's request for an extension of time to file its recommendation is granted.

Staff shall submit its recommendation no later than July 31, 2020.

2. This order shall be effective when issued.
