ORDER DIRECTING EXPEDITED RESPONSES TO REQUEST FOR EXTENSION OF TIME

On April 21, 2020, Spire Missouri, Inc. d/b/a Spire (Spire) submitted an application requesting financing authorization in the amount of \$750 million through September 30, 2023. The Commission directed a response from the Staff of the Missouri Public Service Commission (Staff) no later than June 22, 2020. On June 19, 2020, Staff filed a request for an extension of time to July 12, 2020.

Staff's request for an extension was due to Spire's tender offer, the complexity of that issue, and the limited time to analyze the new data and conduct additional discovery, if necessary.

The Commission will direct expedited responses to Staff's request for an extension due to the pending deadline.

THE COMMISSION ORDERS THAT:

1. Any parties wishing to respond to Staff's request for extension must file their response no later than noon on June 22, 2020.
2. This order shall be effective when issued.
