On April 21, 2020, Spire Missouri, Inc. d/b/a Spire (Spire) submitted an application requesting financing authorization in the amount of \$750 million through September 30, 2023. The Commission directed a response from the Staff of the Missouri Public Service Commission (Staff) no later than June 22, 2020. On June 19, 2020, Staff filed a request for an extension of time to July 10, 2020.

Staff's request for an extension was due to Spire's tender offer, the complexity of that issue, and the limited time to analyze the new data and conduct additional discovery, if necessary.

Due to the pending deadline, the Commission ordered expedited response to Staff's request. No parties objected or otherwise responded.

The Commission considers the unopposed request to be reasonable and will grant it.

Staff's request for an extension of time to file its recommendation is granted.
 Staff shall submit its recommendation no later than July 10, 2020.
