ORDER DIRECTING NOTICE, SETTING INTERVENTION DEADLINE, AND DIRECTING FILING OF STAFF RECOMMENDATION

On June 13, 2025, Boycom Cablevision, Inc. (Boycom) applied for designation as an Eligible Telecommunications Carrier (ETC) in the state of Missouri. Specifically, Boycom will offer Lifeline voice and broadband service to qualifying low-income consumers.

Notice of the application shall be sent to all incumbent and competitive local exchange carriers certificated to provide service in Missouri. The Commission will also set a deadline for intervention requests and will direct the filing of a recommendation by the Staff of the Commission (Staff).

THE COMMISSION ORDERS THAT:

1. The Commission's Data Center shall send notice of this application to all eligible telecommunications carriers certificated to provide service in Missouri.
2. Any request to intervene shall be filed with the Commission no later than July 14, 2025. Such applications shall be filed with:

3. Staff shall file a recommendation regarding this application, or a request for an extension of time, no later than July 24, 2025.
