**Re: Tariff Schedule to Adjust FAC Rate of Evergy Missouri West**

Dear Ms. Dippell:

Pursuant to 20 C.S.R. 4240-20.090(8) of the regulations of the Missouri Public Service Commission (“Commission”), Evergy Missouri West, Inc. d/b/a Evergy Missouri West or the “Company” hereby submits proposed rate schedules to adjust charges related to the Company’s approved Fuel Adjustment Clause (“FAC”). The proposed rate schedule bears an issue date of June 30, 2025, and an effective date of September 1, 2025.

For the 36th accumulation period covering the period of December 2024 through May 2025, Evergy Missouri West’s actual FAC includable costs were higher than the base energy costs included in base rates by approximately \$9 million. In accordance with the Commission’s rule and the Company’s approved FAC, Evergy Missouri West has calculated the FAC tariff that provides for a change in rates to return to customers 95% of those cost changes, or approximately \$8.6 million. In addition, a true-up filing is being made concurrent with this filing covering the 33rd accumulation period of June 2023 through November 2023 and its corresponding recovery period of March 2024 through February 2025. The proposed true-up amount consists of an under-recovery of \$743,077. In summary, these amounts combined including an interest credit amounting to (\$409,319) result in a proposed 36th accumulation period FPA of \$8.9 million to be collected from customers.

The proposed FAC charge for residential customers is a credit of (\$0.00164) per kWh. Based on usage of 1,000 kWh per month, the customer will see a monthly credit of (\$1.64). This represents an increase of \$1.81 to an Evergy Missouri West residential customer’s monthly bill compared to the current monthly FAC credit of (\$3.45).
