### **WNAR**

6. The Company's WNAR Tariff requires the Company to make an annual rate filing to adjust its revenue to account for the effects of abnormal weather. The rate adjustment is effective for a period of 12 months.

7. The Revised Tariff Sheet, P.S.C. MO. No. 9, Fourth Revised Sheet No. 13.9, was filed by the Company on July 1, 2025, to become effective on September 1, 2025. The existing WNAR rates will zero out as of September 1, 2025, and this update to the WNAR will allow the rider to continue without interruption.

8. The new Weather Normalization Adjustment Rider (WNAR) rate is \$0.05128 per Ccf of gas used for Spire East and \$0.03246 per Ccf of gas used for Spire West. For the average

Spire East residential customer, the decrease is \$1.55 per month, and for the average Spire West residential customer, the decrease is \$1.41 per month. The actual change to a customer's bill will vary depending on the customer's usage.

**WHEREFORE**, for all the foregoing reasons, Spire Missouri respectfully requests that the Commission approve this Application, order the proposed WNAR Tariff Sheet to become effective on September 1, 2025, and grant any other relief as is just and reasonable.
