## ORDER DIRECTING STAFF RECOMMENDATION AND SETTING TIME FOR RESPONSES

Issue Date: July 1, 2025

Effective Date: July 1, 2025

On July 1, 2025, Spire Missouri Inc. (Spire Missouri) filed proposed revisions to its Weather Normalization Adjustment Rider (WNAR) tariff sheet, assigned Tracking Number JG-2026-0001. Spire Missouri projected that the changes to the WNAR tariff sheet will decrease the monthly bill of the average Spire East residential customer by \$1.55 per month. For the average Spire West residential customer, the decrease is \$1.41 per month. The tariff sheet bears a September 1, 2025, effective date.

The Staff of the Commission (Staff) will be directed to file a recommendation. The Commission will establish a deadline for any other entity to file a response to the proposed tariff changes and/or to the Staff recommendation.

**THE COMMISSION ORDERS THAT:**

1. No later than August 1, 2025, Staff shall file a recommendation regarding Tracking No. JG-2026-0001.
2. Any responses to Spire Missouri's application or Staff's recommendation shall be filed no later than August 8, 2025.
3. This order is effective when issued.
