**ORDER DENYING MOTION FOR REHEARING**

On June 20, 2025, the Commission issued its *Order Rejecting Complaint*. That order became effective on June 30, 2025. Robert Davis filed a timely application for rehearing and objection to a Commission final order.

Section 386.500.1, RSMo, indicates the Commission shall grant an application for rehearing if “in its judgment sufficient reason therefor be made to appear.” In the judgment of the Commission, the applicant has not shown sufficient reason to rehear his requests to proceed without correcting a deficiency with the complaint regarding the legal representation of a trust before the Commission. Therefore, the Commission will deny Robert Davis’ application for rehearing and objection to a final Commission order.

1. Robert Davis’ *Motion for Rehearing and Objection to Final Order with Submission of New Evidence* is denied.
2. This order shall be effective when issued.

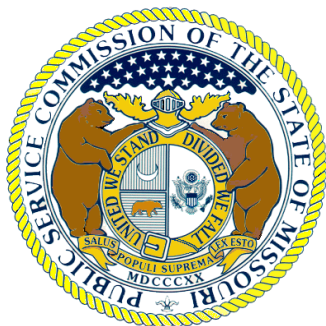
