NOTICE OF APPEAL PURSUANT TO § 386.510 RSMo

TO THE CLERK OF THE COURT AND ALL INTERESTED PARTIES:

NOW COMES Appellant, Robert L. Davis Jr., Trustee of Musiqaa Rayiys Bey PLT, and hereby files this **Notice of Appeal** pursuant to § 386.510 RSMo, appealing the **Final Order issued by the Missouri Public Service Commission** in Case No. GC-2025-0276, dated **July 2, 2025**, which denied Appellant’s Motion for Rehearing and Objection.

Appellant respectfully requests the Missouri Court of Appeals, Western District, to inquire into and determine the **reasonableness and lawfulness** of the Commission’s ruling, which denied Appellant the right to proceed in trustee capacity on behalf of a non-statutory ecclesiastical trust. This denial obstructs equitable access and procedural fairness guaranteed under the Missouri Constitution and relevant statutory authority.

STATEMENT OF ISSUES ON APPEAL:

1. Whether the Missouri Public Service Commission erred in concluding that a trustee of a non-statutory ecclesiastical trust must be a licensed attorney to bring a formal complaint.
2. Whether the Commission's denial of the trustee's standing constitutes an unlawful restriction on access to administrative remedies.
3. Whether the Commission's ruling contradicts statutory and constitutional protections for trustees operating in fiduciary, non-commercial, administrative capacity.
4. Whether the Commission engaged in impermissible gatekeeping in a matter concerning offset billing and utility-backed financial instruments.

STATEMENT REGARDING RECONCILIATION REQUIREMENT:


Pursuant to § 386.420(4) and § 386.510 RSMo, Appellant notes that no reconciliation report is included with this Notice of Appeal because the Commission issued no substantive ruling on utility rates, billing data, or monetary relief. The case was dismissed procedurally without an evidentiary hearing or billing impact analysis. Accordingly, no reconciliation is required.


