## **ORDER SETTING ADDITIONAL LOCAL PUBLIC HEARING**

On May 20, 2025,<sup>1</sup> the Commission ordered seven local public hearings to be held and provided a schedule for those seven local public hearings. Pertinent to this order, the schedule included a local public hearing to be held in Aurora, Missouri, at noon on Thursday, July 24.

On July 3, counsel for Empire District Electric Company d/b/a Liberty emailed the regulatory law judge regarding an issue with the hearing notice that was delivered to customers via billing insert. The notice that Liberty provided to customers gave the correct date of the Aurora local public hearing, but incorrectly indicated a starting time of 6:00 p.m.

Counsel for Liberty suggested that one way to address the error would be to hold two local public hearings in Aurora, one hearing at noon and one hearing at 6:00 p.m. Counselors for the Staff of the Commission, the Office of the Public Counsel, and the Empire District Retired Members & Spouses Association, LLC all communicated their support for the additional local public hearing. Thus, all communicating parties supported holding two local public hearings in Aurora, at noon and 6:00 p.m.

The Commission's foremost concern is for the customers who have been advised of a 6:00 p.m. hearing in Aurora. It would be unlikely that subsequent communications could completely correct the misstatement; therefore, the Commission will add a local public hearing to its schedule, to be held at 6:00 p.m. in Aurora.

Because the bill insert sent to Liberty's customers did not list the noon local public hearing that was ordered, the Commission will order that Liberty provide an additional notice to its customers with a schedule of all hearings to be held. The Commission will also order that Liberty track the costs associated with providing the additional notice, including but not limited to the costs of postage, employee time, and third-party vendor costs.

For the convenience of the parties, the Commission will restate the complete local public hearing schedule and procedures below.

### THE COMMISSION ORDERS THAT:

1. A local public hearing shall be held in Aurora, Missouri, at 6:00 p.m.

2. Liberty shall provide a corrected physical (non-electronic) notice to its customers indicating all hearing dates as updated and otherwise as previously ordered. Liberty shall file a copy of the notice provided to customers as a result of this order within 10 days of notice being sent. Liberty shall track the costs associated with this additional notice as described in the body of this order.

If prompted for a password, enter 0261. No computer or internet connection is necessary to participate by telephone a standard telephone connection (landline or cellular) is all that is needed.
  - b. To attend **by video/internet** visit the website at <u>www.webex.com</u> or download the Cisco WebEx Meetings application. At hearing time, enter the corresponding access code and password listed above.

6. Each public hearing will begin with a question-and-answer session. Public

testimony will begin at the conclusion of the question-and-answer session.

7. The Commission's Public Policy and Outreach Department shall make an informal presentation and conduct a question-and-answer session for the public at the beginning of each in-person or virtual local public hearing.

8. Liberty, Staff, and OPC shall make a representative available to address substantive issues during the question-and-answer sessions.

9. Liberty shall provide notice within the ten days prior to the local public hearing via text message and/or email to customers signed up to receive electronic messages from Liberty

10. If possible, members of the public wanting to participate in a hearing should register by sending their first and last name to pscinfo@psc.mo.gov, or by calling (800) 392-4211 no later than 5:00 p.m. the day before the hearing. Any person may participate at any of the hearings, but are encouraged to attend the hearing closest to their service area for the most relevant information.

11. Any person who needs an accommodation to participate in the hearing should call the Public Service Commission's Hotline at (800) 392-4211 (voice) or Relay Missouri at 711 before the hearing.
