## INVITATION TO FILE COMMENTS REGARDING COSTS OF COMPLIANCE

Subsection 536.200.3, RSMo (Supp. 2019), requires the Commission to review the fiscal note that it attached to its 2018 rescission and amendment of the fuel adjustment clause rules at the end of the first full fiscal year following the implementation of the rules.

The Commission amended 4 CSR 240-20.090 and rescinded 4 CSR 240-3.161.<sup>1</sup>

As part of its review, the Commission's Staff filed a motion on June 23, 2020, asking the Commission to invite interested stakeholders to offer comments about the accuracy of the fiscal impact stated in the fiscal note that accompanied the rulemaking. The Commission will do so.

### THE COMMISSION ORDERS THAT:

1. Comments regarding the actual cost of compliance of the above-listed rules shall be filed with the Commission no later than July 23, 2020.
2. The Commission's Data Center shall provide a copy of this order to all persons who filed comments regarding the rule.
3. This order shall be effective when issued.
