## INVITATION TO FILE COMMENTS REGARDING COSTS OF COMPLIANCE

Subsection 536.200.3, RSMo (Supp. 2019), requires the Commission to review the fiscal note that it attached to its 2018 rescission and amendment of several natural gas safety rules at the end of the first full fiscal year following the implementation of the rules. The rules rescinded were:

4 CSR 240-3.270  
4 CSR 240-3.280  
4 CSR 240-3.290  
4 CSR 240-3.295

The rules amended were:<sup>1</sup>

4 CSR 240-40.020  
4 CSR 240-40.030  
4 CSR 240-40.080

As part of its review, the Commission's Staff filed a motion on June 23, 2020, asking the Commission to invite interested stakeholders to offer comments about the accuracy of the fiscal impact stated in the fiscal notes that accompanied the rulemaking. The Commission will do so.

<sup>1</sup> Effective August 28, 2019, all of the Commission's regulations were transferred from the Department of Economic Development's (DED) Title 4 to the Department of Commerce and Insurance's (DCI) (formerly Department of Insurance, Financial Institutions and Professional Registration) Title 20. The amended rules can now be found at 20 CSR 4240-40.020, 20 CSR 4240-40.030, and 20 CSR 4240-40.080.


