INVITATION TO FILE COMMENTS REGARDING COSTS OF COMPLIANCE

Section 536.200.3, RSMo (Supp. 2019) requires the Commission to review the fiscal note that it attached to its 2018 adoption and rescission of the several rules at the end of the first full fiscal year following the implementation of the rule.

The rules adopted were¹:

4 CSR 240-40.085
4 CSR 240-40.090

The rules rescinded were:

4 CSR 240-3.235
4 CSR 240-3.260
4 CSR 240-3.275

As part of its review, the Commission's Staff filed a motion on June 23, 2020, asking the Commission to invite interested stakeholders to offer comments about the accuracy of the fiscal impact stated in the fiscal note that accompanied the rulemaking. The Commission will do so.
