Section 536.200.2, RSMo 2016 requires the Commission to review the fiscal note that it attached to its 2018 rescission of the several manufactured housing rules at the end of the first full fiscal year following the implementation of the rule. The rules rescinded were:

As part of its review, the Commission's Staff filed a motion on June 23, 2020, asking the Commission to invite interested stakeholders to offer comments about the accuracy of the fiscal impact stated in the fiscal note that accompanied the rulemaking. The Commission will do so.
