### MOTION TO CANCEL REGISTRATION

**COMES NOW** the Staff of the Missouri Public Service Commission ("Staff") and moves for the Missouri Public Service Commission ("Commission") to cancel the registration to provide interconnected voice over internet protocol ("iVoIP") service in Missouri of Hypercore Networks Inc. ("Company") and states:

- 1. On March 20, 2018, the Commission granted a registration of authority to provide iVoIP service in Case No. DA-2018-0235, to the Company.
- 2. On May 23, 2024, the Company notified the Commission that it no longer wished to retain its registration to provide iVoIP services in Missouri in an indication on its Statement of Revenue filed for calendar year 2023.
- 3. Pursuant to 20 CSR 4240-28.011(3), a company may cancel a certificate of service authority or registration by filing a letter signed by the company's official that identifies when and which certificate, registration, and any applicable tariff to cancel. The Rule states the letter should be electronically filed in the Commission's Electronic Filing and Information System ("EFIS").
- 4. The Company properly submitted notice to the Commission requesting cancellation of its authority to provide iVoIP services in Missouri. An officer of the Company signed the statement requesting cancellation of the company's registration,

and the Company filed the statement in EFIS. The Company does not have a currently effective tariff.

5. The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests a hearing. State ex rel. Rex Deffenderfer Enterprises, Inc. v. Public Service Commission, 776 S.W.2d 494 (Mo. App. W.D. 1989).

WHEREFORE, Staff respectfully recommends the Commission cancel Hypercore Networks Inc.'s authority to provide iVoIP service in Missouri.
