On June 23, 2020, Union Electric Company, d/b/a Ameren Missouri (Ameren Missouri), filed an application seeking variance from certain provisions of Commission Rule 20 CSR 4240-20.100(8)(A), concerning information to be reported in Ameren Missouri's Annual Renewable Energy Standard Compliance Report. Ameren Missouri also seeks waiver of the 60-day notice requirement under 20 CSR 4240-4.017.

The Commission will direct notice of the application be provided to the news media and the General Assembly. In addition, the Commission will set a deadline for interested parties to intervene.

THE COMMISSION ORDERS THAT:

1. The Commission's Public Policy and Outreach Department shall make notice of this order available to members of the General Assembly representing customers in Ameren Missouri's service area and to the news media in Ameren Missouri's service area.

2. The Commission's data center shall provide a copy of this order to every party in Ameren Missouri's most recent rate case, File No. ER-2019-0335.

3. Any person wishing to intervene in this matter shall file an application to intervene no later than July 10, 2020.

4. This order shall be effective when issued.
