**ORDER DIRECTING A STAFF TARIFF RECOMMENDATION
AND SETTING TIME FOR RESPONSES**

On July 2, 2025, Evergy Missouri West, Inc. d/b/a Evergy Missouri West filed tariff sheets, assigned Tracking No. JE-2026-0003, to correct prior tariff sheets that were inadvertently not withdrawn. The corrective tariff sheets bear an effective date of August 1, 2025. The Commission will direct its Staff to analyze the tariff sheets and file a recommendation. The Commission will also set a deadline for any other responses to Evergy Missouri West’s tariff sheets.

THE COMMISSION ORDERS THAT:

1. Staff must file a recommendation regarding Evergy Missouri West’s tariff sheets no later than July 16, 2025.
2. Any other responses to Evergy Missouri West’s tariff sheets must be filed no later than July 16, 2025.
3. This order is effective when issued.
