On June 17, 2020, the Commission issued its *Order Setting Virtual Hearing and Establishing Procedure for Collecting Public Comment*. Consistent with Commission Rule 20 CSR 4240-10.075(7), the order provides written comment may be received by no later than July 22, 2020. The order also requires Raytown Water Company to mail to customers a written notice of the hearing, which must also include the deadline for submission of written comments. On June 25, 2020, Staff filed a copy of such a notice. The notice indicates written comments must be submitted by July 9, 2020, rather than July 22, 2020.

The Commission will direct the parties to file, by no later than June 29, 2020, suggestions for correcting the apparent error.

**THE COMMISSION ORDERS THAT:**

1. Staff shall file suggestions for correcting the apparent error by no later than June 29, 2020. Alternatively, the parties may file a joint proposal by no later than June 29, 2020.
2. This order shall be effective when issued.
