ORDER APPROVING CORRECTION AND DIRECTING FILING

On June 17, 2020, the Commission issued its *Order Setting Virtual Hearing and Establishing Procedure for Collecting Public Comment*. Consistent with Commission Rule 20 CSR 4240-10.075(7), the order provides written comment may be received by no later than July 22, 2020. The order also requires Raytown Water Company to mail to customers a written notice of the hearing, which must also include the deadline for submission of written comments. On June 25, 2020, Staff filed a copy of such a notice, which indicated a July 9, 2020 deadline for written comments.

On June 25, 2020, the Commission directed the parties to file suggestions to correct the apparent error. On June 26, 2020, Staff filed a joint proposal on behalf of the parties, which suggests Raytown will mail its customers a letter of correction providing the July 22, 2020 deadline for written comment. Staff's filing includes, as Appendix A, a copy of a suggested letter of correction. The Commission will approve the proposal.

THE COMMISSION ORDERS THAT:

1. Raytown Water shall mail a written notice of correction to customers, as provided above, no later than July 1, 2020.

2. No later than July 2, 2020, Staff shall file a status report advising whether a corrected notice has been mailed. Staff's status report shall include a copy of such notice, if additional revisions are made.

3. This order shall be effective when issued.
