On June 25, 2020, the Commission held an evidentiary hearing in this case. The Commission will issue orders concerning the exhibits which were admitted into evidence in the hearing.

THE COMMISSION ORDERS THAT:

1. This order shall apply to the exhibits which were tendered and admitted into evidence as a matter of record during the June 25, 2020, hearing.
2. No later than July 9, 2020, each party shall file that party's exhibits in EFIS.
3. Each exhibit shall be identified by:
 - The name of the party filing the exhibit
 - The exhibit number assigned when the exhibit was admitted into evidence
 - The title of the exhibit
4. No later than July 9, 2020, each party shall also provide that party's exhibits to the court reporter using the same identifying information used in the EFIS filing.

5. No later than July 9, 2020, the Commission Staff shall confer with all parties concerning their exhibits and prepare and file an exhibit list in EFIS duly identifying all exhibits filed by all parties. The Commission Staff shall simultaneously provide the exhibit list to the court reporter.

6. This Order shall be effective when issued.
