# ORDER DISMISSING CASE

Issue Date: July 9, 2025

Effective Date: July 19, 2025

The Commission stayed this case because the parties were awaiting a change to the Commission's Affiliate Transactions Rule that would affect this Cost Allocation Manual (CAM) case. The old Affiliate Transactions Rule<sup>1</sup> was rescinded May 30, 2025, and replaced by the current rule 20 CSR 4240-10.155, effective May 30, 2025.

Union Electric Company d/b/a Ameren Missouri and Staff filed a motion to dismiss on July 3, 2025. The Office of the Public Counsel does not oppose the motion to dismiss, but reserves the right to raise objections and arguments concerning Ameren Missouri's CAM and affiliate transactions in the future.

Commission Rule 20 CSR 4240-2.116(1) states that once prepared testimony has been filed, an applicant may only dismiss an application by leave of the Commission. Prepared testimony was previously filed in this case. However, Ameren Missouri and Staff no longer wish to pursue this case. Therefore, the Commission will grant the motion to dismiss. The Commission finds it reasonable to make this order effective in less than 30 days.

**THE COMMISSION ORDERS THAT:**

1. Ameren Missouri and Staff's *Motion to Dismiss Case* is granted.
