The Empire District Electric Company, The Empire District Gas Company, Liberty Utilities (Midstates Natural Gas) Corp., and Liberty Utilities (Missouri Water) LLC, all subsidiaries of Algonquin Power & Utilities Corp., have filed an application with the Missouri Public Service Commission seeking approval of their Cost Allocation Manual (CAM). At the request of the parties, proceedings in this matter are currently stayed while the Commission considers changes to its rules regarding affiliate transactions. The parties filed a status report on June 30, 2020, asking that proceedings remain stayed.

The Commission will continue to stay these proceedings and will direct the parties to file a status report in six months.
