On June 12, 2020,<sup>1</sup> Confluence Rivers Utility Operating Company, Inc. (Confluence) filed an Application and Motion for Waiver with the Missouri Public Service Commission seeking authority to purchase substantially all of the water and/or sewer assets of Terre Du Lac Utilities Corporation (Terre Du Lac). On June 24, Confluence filed a motion to consolidate files WM-2020-0403 and SM-2020-0404. Confluence states the Commission's Staff and the Office of the Public Counsel do not object, and no response has been filed,

The Commission finds Confluence is the applicant in both cases. Both Confluence Rivers and Terre Du Lac are water and sewer corporations and parties in both cases. Confluence states the two files concern the same subject matter, similar parties, and common questions of law and fact. Directly appropos consolidation, Confluence states the
