On June 12, 2020,<sup>2</sup> Confluence Rivers Utility Operating Company, Inc. (Confluence) filed an Application and Motion for Waiver with the Missouri Public Service Commission seeking authority to purchase substantially all of the water and/or sewer assets of Terre Du Lac Utilities Corporation (Terre Du Lac). On June 15, the Commission issued its Order Directing Notice and Establishing Time for Filings. This Order directed Staff to file a pleading no later than July 7 advising when it anticipated filing its recommendation in this matter.
