On June 23, 2020, Union Electric Company, d/b/a Ameren Missouri (Ameren Missouri) filed an application seeking variance from certain provisions of Commission Rule 20 CSR 4240-20.100(8)(A), concerning information to be reported in Ameren Missouri's Annual Renewable Energy Standard Compliance Report.

The Commission will direct the Commission's Staff to file a recommendation.

THE COMMISSION ORDERS THAT:

1. No later than July 22, 2020, the Commission's Staff shall file a recommendation regarding Ameren Missouri's application, or a status report indicating when it expects to file a recommendation.
