On February 26, 2020,<sup>1</sup> this case was set for an evidentiary hearing on April 1. On March 23, the case was continued and all procedural scheduling orders were suspended due to the COVID19 virus. The Commission finds that because of the continuing virus pandemic, no in-person hearing can be conducted in a timely manner and will set the case for an online evidentiary hearing, to be conducted either by Zoom or Webex. The Commission will order the parties to confer and file a proposed amended procedural schedule.

**THE COMMISSION ORDERS THAT:**

1. An evidentiary hearing shall be held in this case online by either Zoom or Webex.
2. No later than July 24, 2020, the parties shall confer and file a proposed procedural schedule.
