On January 6, 2025, Union Electric Company d/b/a Ameren Missouri filed notice, pursuant to Commission Rule 20 CSR 4240-4.017(1), indicating its intent to file an application for a certificate of convenience and necessity to construct renewable generation and battery storage facilities. The Commission's rule provides that if the application is not filed within 180 days the noticed case shall close.
