Staff states that the parties have made progress toward a settlement, but no settlement has yet been reached. Staff proposes that the Commission order the parties to file a stipulation or proposed procedural schedule no later than July 31, 2020.

The Commission finds the request reasonable, and will grant it.

1. The parties shall file a stipulation, proposed procedural schedule, or alternative pleading no later than July 31, 2020.
