ORDER DIRECTING EXPEDITED RESPONSES TO SUGGESTED LANGUAGE

On April 21, 2020, Spire Missouri, Inc. d/b/a Spire (Spire) submitted an application requesting financing authorization in the amount of \$750 million through September 30, 2023. Staff's recommendation for approval, with conditions, was filed on July 9, 2020. The Office of the Public Counsel (Public Counsel) responded on July 17, 2020, with suggestions for language to include in the conditions recommended by Staff. Public Counsel states that while the other parties did not oppose its discussed recommendations, those parties have not reviewed Public Counsel's specific language.

The Commission will direct expedited responses to Public Counsel's suggested language.

THE COMMISSION ORDERS THAT:

1. Any parties wishing to respond to Public Counsel's suggested language must file their response no later than noon on July 24, 2020.
2. This order shall be effective when issued.
