## ORDER RECOGNIZING NAME CHANGE

Issue Date: July 22, 2020

Effective Date: August 20, 2020

Whisper ISP, Inc. submitted a letter dated July 9, 2020, advising that it has changed its name Whisper ISP, LLC. The company subsequently filed an updated tariff to reflect the new name. That tariff carries an effective date of August 20, 2020. The Commission's Staff filed a recommendation on July 22, indicating the company has complied with all statutory and regulatory requirements for changing its name. Staff recommends the Commission recognize the name change and allow the updated tariff to take effect by operation of law. The Commission will do so.

**THE COMMISSION ORDERS THAT:**

1. The Commission recognizes the name change of Whisper ISP, Inc. to Whisper ISP, LLC.
2. The revised tariff filed by Whisper ISP, LLC, (Tariff No. YC-2021-0010) will be allowed to take effect on August 20, 2020.
3. This order shall be effective on August 20, 2020.

4. This file shall be closed on August 21, 2020.
