Issue Date: July 22, 2020

On July 9, 2020,<sup>1</sup> the Commission issued its order requiring the parties to file a proposed procedural schedule no later than July 24 and advising the parties the case will be tried online because of the continuing COVID-19 pandemic. On July 21, Ms. Stinnett left a voice mail for the regulatory law judge assigned to the case and asked the case not be tried online because of her concerns about her inability to put on her case effectively by phone. Notice is given pursuant to Commission Rule 20 CSR 4240-4.020(3) and (4).

The Commission always considers the difficulties for all parties, pro se or represented, and for witnesses, presented by an online evidentiary hearing when issuing a procedural order. Here the Commission will consider available facilities in or near Eminence, Missouri, or reasonably convenient elsewhere, which will both accommodate safety concerns and the parties' abilities to present their cases.
