**ORDER DIRECTING RESPONSES TO REQUEST FOR NOTICE
AND REQUEST FOR PUBLIC HEARING**

On March 11, 2020, Confluence Rivers Utility Operating Company, Inc., applied for authority to acquire sewer and water utility assets in transactions with various entities.¹

On July 17, 2020, the Commission’s Staff filed its recommendation. On July 20, 2020, the Office of the Public Counsel (OPC) filed a *Motion to Suspend Current Schedule, Request for Notice to Customers, and Request for Local Public Hearing*.

The Commission will direct Confluence Rivers and Staff to file responses to OPC’s requests for notice and local public hearing. To enable the Commission to consider the parties’ responses, the Commission will suspend any obligation to respond to Staff’s July 17, 2020 recommendation until further order.

THE COMMISSION ORDERS THAT:

1. No later than July 30, 2020, Confluence Rivers and Staff shall file a response to OPC’s request for notice to customers and request for local public hearing.
2. Any deadline for response to Staff’s July 17, 2020 recommendation is suspended until further order.

3. This order shall be effective when issued.


