On June 23, 2025, BrightSpeed Fiber Connection LLC, pursuant to Sections 392.611.4 and 392.550, RSMo, filed an application for authorization to provide Interexchange (IXC) Telecommunications Services in the following exchanges:

The Commission has reviewed the application and finds that it and the attached affidavit comply with the filing requirements set forth in Section 392.550, RSMo.¹ The affidavit attached to the application represents that the company has not had contact with the office of the Commission about any substantive issue connected to the filing.
